Accomplishments: Developed and launched a region wide bike safety public awareness campaign; developed the Biking in Cleveland Guide to educate and encourage more people to ride a bike; and conducted a council candidate survey to educate candidates on relevant cycling issues

Advocacy: Mobilizing an educated cycling constituency in support of innovative bike infrastructure and policies. Including bike lanes, protected bike lanes, bike parking and bike-friendly policies.

Accomplishments: Provided technical assistance to develop bike friendly policies for local governments; advocated for the addition of 5.8 miles of bikeways on Cleveland streets; promoted community engagement at public meetings; and formulated plans to expedite and prioritize future bike facility investment in Cleveland (including plans for protected bike lanes).

Events and Programs: Planning an implementing events and programs that grow and connect an inclusive and diverse cycling community.
