Education: Bike Cleveland is raising awareness around the growing number of people on bikes and their rights as legal road users through public awareness campaigns. We train law enforcement officers how best they can protect cyclists on the road through better enforcement practices as they pertain to people on bikes. Additionally, we provide group riding traffic skills and education through social bike rides and presentations to improve the skills and behavior of our local ridership. We educate businesses on how to become more bicycle friendly for employees and customers, and the benefits in doing so. Finally, we teach municipalities about best practices for bike friendly policy and planning, and the reasons it is important for their communities.

4b (Code:) (Expenses \$ 31,646 including grants of \$) (Revenue \$ 60,001)

Advocacy: Mobilizing an educated cycling constituency in support of innovative bike infrastructure and policies such as, bike lanes, protected bike lanes, bike parking and bike-friendly policies. We act as a portal through which interested people can engage the public process with maximum impact. Understanding our limitations as a small organization, we are expanding bicycle advocacy in Greater Cleveland by creating chapter organizations and supplying them with the financial resources they need to improve conditions in their immediate area.

Accomplishments: Secured a design change to the opportunity corridor to better serve residents most heavily impacted by the project; Advocated for

By having a robust encouragement component to our work we are growing ridership and improving people's comfort level on the road through group participation. Bikes are a fun, healthy, and sustainable activity for people of all ages, and our events and programs are designed to get people outside and engaged in their community.

Accomplishments: Ran the local version of the National Bike Challenge that logged over 800,000 local miles; Planned and implemented seven bike to work day events in addition to over a dozen more biking focused events that got
